## Investment Facilitation – Introduction

- 11th WTO Ministerial Conference in December 2017: 70 WTO Members launched the Joint Initiative on Investment Facilitation for Development.
- A core objective is to facilitate greater participation by developing and least-developed WTO Members in global investment flows.
- Negotiations were concluded successfully in July 2023.
- The WTO Investment Facilitation for Development Agreement, or IFD Agreement, or just IF agreement is the first agreement with a common set of investment facilitation measures agreeable by a vast majority of WTO Members.

### Section II: Transparency of investment measures

## **Transparency of investment measures: Summary of key provisions**

- i. publish investment policy related measures 'of general application' (Art 6.1)
- ii. publish international agreements affecting investment (Art 6.1)
- iii. allow for reasonable time between publication of the text of a law or regulation and the date on which investors must comply (Art 6.2)
- iv. explain the purpose and rationale of new investment laws or regulations (Art 6.3)
- v. make available, via electronic means, information of importance to investors, and keep the information updated (Art 6.4)
- vi. publish information on authorisation requirements and procedures (Art 7)
- vii. use of single information portal (Art 8)
- viii. No fees for investors for access to information/single information portal (Art 9)
- ix. Publish draft laws and regulations of general application, or changes thereto; and documents to allow investors to assess impact on their interests (Art 10)
- x. make publicly available online information on the requirements and procedures for entry and temporary stay of natural persons in its territory (Art 12)

## **Other measures to streamline and speed up administrative procedures not in IF Agreement – examples**

1. Stringency of authorization procedures based on risk assessment.
2. Certain applications could be considered for lighter processing including conditional approval
3. Simplify process for connecting to essential infrastructures such as electricity and water supply.
4. Time-bound authorization processes.
5. Work and residence permits

## **Investment Facilitation Agreement**

### **Section V: Special And Differential Treatment for Developing and Least Developed Country Parties**

- Section is modelled on the approach developed under the Trade Facilitation Agreement.
  - Category A - provisions implemented immediately upon ratification
  - Category B - provisions that developing countries could only commit to implement after a transition period
  - Category C - provisions that can only be implemented when capacity-building and technical assistance has been received
- Interplay future bilateral agreements and categorization of commitments under WTO investment facilitation agreement
